OPEN SESSION

The Town Mayor welcomed Councillor Dixon to his first meeting and all those present.

There were no issues raised by members of the public; Acting Inspector Andy Pullen of Northumbria Police had tendered his apologies.

1. APOLOGIES FOR ABSENCE

Apologies for absence had been received from Councillor Bettison and from the Sheriff.

2. MINUTES

The minutes of the meeting of Berwick-upon-Tweed Town Council held on 16 November 2009 were agreed and signed as a correct record.

The Clerk reported that the EBDA Award had been made to The Gunsgreen House Trust (CO60/09).

It was noted that the developers of the apartments at 7-13 Main Street Tweedmouth had agreed to the name McGregor Court (minute CO61/09).

3. DISCLOSURE OF INTERESTS

Councillors Bowlas, Herdman, Robertson and Simpson, as non-Freemen Trustees, each declared a personal interest in Item13, Finance and Resources Committee.

4. TOWN MAYOR'S ANNOUNCEMENTS

The Town Mayor informed members of the events she had attended as Town Mayor, together with other members of the Civic Party. She made special reference to the successful Christmas lights, which she had switched on. She also reported on the Boxing Day Dip, which it was expected had raised £400.

The Mayor had been pleased to welcome the Coldstream Guards to Berwick on 6 January on their march from Coldstream to London.

Members were advised of the Civic Valentine's Ball which was to be held on 12 February, with tickets available from Councillor Bettison.

5. SERVICE DEVOLUTION

The Town Clerk outlined the discussions and correspondence with Northumberland County Council regarding the proposals for the devolution of a range of services in 2010-11. The Finance and Resources Committee had advised the County Council that members did not consider they were in a position to take these responsibilities on at this time.

Members had indicated, when contacted individually, that they wished to agree with the proposals set out by the Director of Street Scene in a letter dated 5 January 2010, in particular the proposal that discussions on devolving services in 2011-12 should be started as soon as possible. This view had been expressed to the County Council.

- (i) To note and confirm the response to Northumberland County Council as the view of the Council as a whole**

- (ii) **To note the report on service devolution presented to the County Council Executive Committee on 11 January 2010.**
- (iii) **To note the proposal to establish a NALC Larger Councils Forum, at which issues relating to service devolution will be considered and shared**

6. REVIEW OF ISSUES ARISING FROM SEVERE COLD WEATHER

Members raised the following issues arising from the severe cold weather.

- (i) Failure to treat car parks; Castlegate car park was particularly bad.
- (ii) Attempts to contact the County Council call centre over Christmas had elicited the response that local and estate roads and footpaths would not be treated, leading some to be impassable for several days.
- (iii) The policy to keep main roads open had not been followed; Main Street Spittal, a bus route, had not been gritted.
- (iv) It was noticeable that road clearance and gritting had improved once the holiday period was over, but people still had to get about during the Christmas and New year period
- (v) The problems highlighted the need to know what emergency planning arrangements were in place
- (vi) Matters could have been improved if local volunteers had been provided with the tools to carry out clearing and gritting.
- (vii) A review would be undertaken by the County Council over the standard of service provided
- (viii) The number of gritting lorries appeared to be less than it was prior to local government reorganisation.
- (ix) Local bus services were suspended in Main Street Spittal because the road was not safe.
- (x) The location of grit bins needed to be reviewed as they were not all in the most useful locations.
- (xi) The A1 was at times in as poor a state as local roads.

The Clerk said these points would be forwarded to the County Council, which was holding a public Scrutiny Meeting on the subject on 26 January.

Members had mixed views about whether this offer should be accepted; the Mayor was asked to establish what Ms Burn's charges would be and refer these to the next meeting of Council.

- (ii) Request from the Royal Regiment of Scotland for the Town Council to present a Pipe Banner to the Royal Regiment of Scotland, at an estimated cost of £350-£500**

RESOLVED: To welcome the suggestion that the Town Council should present a Pipe Banner to the Royal Regiment of Scotland and agree expenditure of £350-£500.

Councillor Robertson reported on the public meetings which had been held to establish local interest in reviving and developing the twinning links which had previously been established by the Borough Council.

Those attending had expressed enthusiasm for continuing the tradition of establishing links overseas, and it was hoped in future the scope would include both existing twin towns and additional overseas links.

Events were already being planned, and it was hoped that as well as a list of contacts being maintained, there would be a centralised list of forthcoming events in order to avoid clashes.

A further meeting would take place on 25 February 2010 at 7 pm at The Beehive. Members expressed their support for the continuing of international links.
