OPEN SESSION

Councillor Douglas raised the issue of the Car Parking Strategy for Northumberland and the importance of members being aware of what was being proposed, and ensuring there was local input to the debate as it moved towards local consultation.

CO21/11 1. APOLOGIES FOR ABSENCE

Apologies for absence had been received from Councillors Beresford, Bettison, Dixon, Pauline and Smith.

5. PRESENTATION BY SUE MILNER, DIRECTOR OF PUBLIC HEALTH AND PROTECTION FOR NORTHUMBERLAND

Ms Milner described the background to, and nature of, the 'Berwick Project':

- One of six workstreams in the County's Transformation Programme'
- The objective is to try and find ways of spending money more effectively in a geographical locality, by improving delivery of services through a programme of related projects
- The focus was high need households with complex needs, and the basis of the project would be work being carried out in the Three Fields area, and involving a local team.

In response to questions, Ms Milner reported that:

- A project initiation document (PID) set out time-lines for outcomes
- The project was underway already
- Similar work had been trialled elsewhere,
- A lack of consultation with local bodies including the Town Council was acknowledged, although it was recognised that local knowledge was valuable

The Chair thanked Ms Milner for attending the meeting.

CO26/11 6.NCC CONSULTATIONS

(i) Polling districts and polling places

Councillors had no comments to make on the review of polling districts and polling places

(ii) Grounds Maintenance

The Council had been invited to complete a questionnaire from the County Council about the standard of grounds maintenance; it was agreed that members would collate responses individually which would be forwarded to County by the Clerk.

survey was being carried out of existing bins; she was asked to request that this information be forwarded to Town Councillors when available, so that they could add suggested new sites.
