Concerns were also raised about the state of the toilets in Spittal; and the agreed location for the coach park in Chapel Street, which it was suggested was unsuitable due to the size of the vehicles using the entrance and exit routes. It was explained that the issue of the toilets in Spittal had been raised at a meeting of the Environment and Regeneration Committee and a site visit and public meeting was to be discussed with Northumberland County Council Officers. Regarding the coach park in Chapel Street, the Planning Application had been granted approval by Northumberland County Council.
