Grant Awards

The Council aims to promote and protect the quality of life and well-being of those who live in, work in, or visit the local area. To this end, the Council offer grants to local organisations based in, or providing services to the locality, to help them maintain and develop their services, facilities, and activities. Grants are available throughout the year and applications are invited up to the value of £2500 per application. To apply, please look at the Grants Awarding criteria and fill in the Grant Application Form on our website (www.berwick-tc.gov.uk/grant-schemes).

A recent example of a grant awarded by Council was to Greener Berwick to support their Repair Cafe Initiative. Repair Cafés are workshops organised to repair broken household items together, instead of throwing them away. It's a friendly, social space, with a strong sense of common purpose and it's exactly the kind of community initiative that the Council is glad to support. Here's a letter we received after the grant was issued that demonstrates just how important a grant can be to help an organisation get their plans moving:

Dear Gareth,

On behalf of Greener Berwick and the Repair Cafe Team, please could you convey our deepest thanks to the Berwick Town Council Committee for agreeing to provide us with £1536.44 towards the further development of our Repair Cafe Project. This will be such a help towards ensuring that the Repair Cafe Project can continue to grow. It is already proving to be popular with local residents and is now listed on the International Repair Cafe website. https://www.repaircafe.org/en/cafe/berwick-upontweed-repair-cafe/

Receiving your grant has provided the funding needed for Phase One of the Repair Cafe Project, to develop it over the next 6 months. Applying for your grant also gave us the confidence boost to seek further funding to expand the Project for Phase Two, so on the back of this, we have since made a successful application to NCC's Environment and Climate Fund. This will cover a further 6 months for the Repair Cafe and will include the initial development of the Tool Library & Library of Stuff plus storage. This storage will also be used to store gardening equipment for the Community Growing Group, which is currently re-planting beds within Berwick.

It is all looking very positive and is going in the right direction. Tania and I are very grateful to you and Julian for your support and advice with the initial planning phase of our proposal and also for the Town Council financially supporting us in the development of the Repair Cafe, as part of our Zero Waste Vision.

Town Planting FINANCE OF THE PROPERTY OF THE

The plans for planting around town are well underway and we aim to build on our first attempt this year. One of our innovations will be that the Council will be growing its own bedding plants from plugs, rather than fuller grown plants. Not only will this reduce our carbon impact it will reduce the costs involved in planting. We've rented a piece of land from NCC at the Ramparts, near to our depot and we will be installing polytunnels in the new year in preparation for planting up in the spring.



You may see some odd bits of equipment attached to lampposts and street signs. These are passive monitoring devices for nitrogen dioxide gas. These are exposed for approximately one month and swapped on a given date for another, year round. The tubes are sent to a laboratory which determines the nitrogen dioxide concentration at the tube's location for the period it is exposed. They are installed by NCC as part of our their requirements to monitor and report on air quality within Northumberland.

Council Audit 2023

Whenever concerns are raised about the standards of our work at the Town Council, we take them seriously. It's absolutely right that we are scrutinized, audited and challenged. It's our job to respond to those challenges. Sometimes those challenges aren't always easy to follow, sometimes the facts get lost. Want an example? A local publication recently reported that we handle £1m a year. We don't – they got to that figure by double counting income received and cash in hand – but that's a good example of how confusing our finances can be, and why we have to be open and honest.

We got our Internal Audit report for 2022-23 in June. We published it, and reported it to council. We went further. As soon as we were aware there were issues (with the Asset Register) we told council's Budget and Administration committee about them, even before we had the report, and explained what we'd done to deal with them. What went wrong with the Assets Register? Council moved offices during the year, and some items of redundant furniture were disposed of. How they were disposed of, and how it was recorded, was not done well, but the Internal Auditor reported that the difference was not material to the total value of the assets.

Overall, the Internal Auditor concluded that they had "satisfied [them]selves with the standard of the accounting records and internal controls throughout the accounting period and that's why they signed off the Internal Audit part of our Annual Return.

The issue with the External Auditors was more significant. Each year we have to fill in an Annual Return. We're expected to make adjustments to the figures for Income and Expenditure if, as sometimes happens, we pay in advance for goods that won't be delivered until the next financial year, or we receive income that we're not actually owed until the next year (like an allotment tenant paying two years rent in advance, for instance).

The Annual Return doesn't allow for these sorts of adjustments, so we have to do some accountancy work in the background. In the past this has been sufficient to satisfy our External Auditors but this year they didn't accept this and there were prolonged discussions about how this should have been reported. Unfortunately this to and fro led to us missing the deadline with regard to submitting evidence.

We're sorry that happened, and we take full responsibility for it. It doesn't mean that the conclusions of the Internal Audit reports are wrong; it means we have to work harder to provide documents in the format the Auditors ask of us.

Part of the process of being better at this, is to bring in new Internal Auditors who will give us two reports a year, and who specialise in Parish Councils. Their Interim conclusion for 2023-24 is 'Having reviewed the Council, I believe they are at a high standard whilst there is always room for continuous improvement even in a high standard Town Council.' Those are the standards we will continue to work towards.
