C001/10 1. ELECTION OF TOWN MAYOR

The retiring Town Mayor, Councillor F Simpson, proposed, and Councillor H Bettison seconded, the proposition that Councillor J Waterhouse be elected Town Mayor of Berwick-upon-Tweed for the year 2010/2011.

RESOLVED: That Councillor J Waterhouse be appointed Town Mayor of Berwick-upon-Tweed for the year 2010/2011.

The Town Mayor signed the Declaration of Acceptance of Office and took the Chair for the remainder of the meeting.

Following her formal presentation to the Town Council, the Town Mayor gave a short address thanking the outgoing Town Mayor and introduced members of the incoming Civic Party, including Mayor's Consort Mr Cameron Waterhouse.

2. ELECTION OF DEPUTY TOWN MAYOR C002/10

The Town Mayor proposed, and Councillor F Simpson seconded, the proposition that Councillor A Bowlas be elected Deputy Town Mayor of Berwick-upon-Tweed for the year 2010/2011, following which a second nomination was received.

Councillor J Beresford proposed, and Councillor I Hunter seconded, the proposition that Councillor J Robertson be elected Deputy Town Mayor for the year 2010/2011.

The Acting Town Clerk explained the options, as set out in the Council's standing orders, for conducting a vote in order to secure the election the Deputy Town Mayor. Councillor H Bettison proposed and Councillor G Hill seconded, the proposition that a secret ballot be carried out.

The result of the secret ballot was as follows: 8 votes in favour of the election of Councillor A Bowlas as Deputy Town Mayor for the ensuing year, 5 in favour of Councillor J Robertson, and one abstention. It was therefore

RESOLVED: That Councillor A Bowlas be appointed Deputy Town Mayor of Berwick-upon-Tweed for the year 2010/2011.

The Deputy Town Mayor signed the Declaration of Acceptance of Office.
