CO88/13 5. LOCAL DEVELOPMENT PLAN

Following consideration by four members at the foregoing Strategy and Policy Group meeting, and further discussion by those present, it was agreed that the Council should respond to the Core Strategy Consultation (Preferred Options on Housing, Employment and Green Belt) making the following points:

1. (Reference Question 11, comments on preferred strategic approach to

growing and diversifying the economy). Concern to be expressed at the lack of tertiary education accessible to young people in the Berwick-upon-Tweed area.

2. (Reference Question 15, comments on the delivery of affordable housing). Request to be made that measures should be put in place to ensure any cash contribution in lieu of a developer providing an affordable housing element should remain within the Berwick community for five years.
3. (Reference Question 38, comments on the approach to housing in the settlement of Berwick). Support to be expressed for the two proposed sites North West of Berwick and South of East Ord, but a request to be made that sites at Springhill and Roberts Lodge, as well as brownfield sites, should be included in preferred options.

The Clerk would draft a response and circulate it to members for agreement before responding to Northumberland County Council.
