Members considered the proposed budget which had been circulated . They were advised that the County Council had written to all local councils advising them to delay setting their precepts until January, by which time further information would be to hand about the financial settlement for the County Council, and the extent to which the County Council might compensate local councils for the reduction in tax base owing to the localising of council tax support.

Members agreed that the budget brought Berwick-upon-Tweed more in line with other local councils of a comparative size.

RESOLVED: (i) To agree the proposed budget in principle, but postpone formal adoption until further information which might impact on the tax base, and therefore the precept, had been received from Northumberland County Council; and (ii) to hold an extraordinary meeting in January, if required, to review the budget in the light of any new information.

Councillor Hunter was requested to ask Northumberland County Council whether the car parking revenue generated in the Town Council area car parks could be ring-fenced for re-investment within Berwick.
